PAYC JUNIOR MEMBERSHIP INFORMATION

Welcome to PAYC! Any young person of good moral character who supports the purposes of PAYC and exhibits a passion for sailing is eligible for membership.

The criteria for Junior Membership are:

- a. Must be 12 years or older but less than 18 years of age, with exceptions for applicants who are actively pursuing high school studies.
- b. Joins as an individual, not as a family
- c. Subject to the service hour requirement of subsection (e) below, membership may be renewed annually until the Junior Member becomes 18 years old or completes his/her high school studies.
- d. Applications for membership or annual renewal of membership must be accompanied by a medical information form (see separate document)
- e. During the calendar year, the Junior Member, and/or a parent/custodial designee of the Junior Member, must contribute 10 hours of service in support of PAYC. This may include working on the boats, helping at regattas and/or PAYC events, assist in promoting the Sailing Program, or as directed by the Commodore.

The privileges and responsibilities of a Junior Membership are:

- a. Have full PAYC privileges, with the exception of voting or holding office
- b. Each Junior Member shall have a designated adult chaperone at PAYC functions when the bar is open.
- c. Pay the annual membership dues.

As a Junior Member your activities will center on participation in PAYC's Sailing Program activities, which requires the following:

- a. You are required to provide your own Type III personal flotation device (PFD), which must be Coast Guard approved and the proper size for your weight and build.
- b. You must provide proof of ability to swim, such as an American Red Cross certification
- c. You must wear shoes at all times while you are in a boat, on the docks, or in the boat launching area.
- d. You must wear a wetsuit at all times when sailing.

You understand that by enrolling and participating in PAYC Sailing Program activities, you agree to obey all event procedures as set forth by PAYC. You agree that you will use utmost care in the use of the boats and equipment. You understand that if you fail to abide by the event procedures, you will be suspended from the Program although you may wish to participate in other PAYC activities.

Agreement and Liability Release

I agree to assume the obligation of providing myself (and/or my child) with the required PFD, shoes, and a wetsuit. I further agree to assume the obligations of the expenses of repair and/or replacement of PAYC boats and equipment whose loss or damage is attributable to my (and/or my child's) reckless or irresponsible behavior.

In consideration for my child being permitted to participate in the PAYC Sailing Program, **I hereby release the Port Angeles Yacht PAYC, its employees, agents, insurers, members, volunteers, representatives, trustees and officers (hereinafter collectively and individually referred to as "PAYC") and agree to hold PAYC harmless from any and all claims for injuries to me (and/or my child) or damages suffered by me (and/or my child), including wrongful death, arising out of or related to the PAYC Sailing Program. I further accept full responsibility of the cost of treatment for any injury suffered by me (and/or my child) while participating in the PAYC Sailing Program.**
